

2011 Census results for Stinsford – summary by Mary, Feb 2019

Hi Sally,

I have extracted some data from the 2011 Census.

Points of interest (some lighthearted) and all carry a health warning as the numbers are low so although there are some differences with West Dorset overall, they may not be statistically significant.

Stinsford had 334 usual residents in 2011. Slightly more males than females- bucking the trend for West Dorset and UK. The average age of Stinsford residents was 44.7 (mean) and 49 (mode). Very similar to all of West Dorset and to my mind lower than I was expecting.

Of the total 149 household spaces 128 (90%) had at least one usual resident and 21 (14.1%) had no usual resident. The figure for no usual resident across West Dorset is 10%

16.5% of residents don't have passports (20% in WD)- of interest but irrelevant for our work therefore not in the attached document

Houses tend to be a little bigger than those across the area- more detached premises and more rooms /bedrooms per household. Warning- pretty small numbers

Owned vs rented is pretty similar to the area but with less social renting than West Dorset as a whole

I think the most striking difference comes when looking at car/van availability. Stinsford has a lower percentage of non-vehicle households and the distribution of multiple vehicles per household is much higher than across West Dorset perhaps reflecting the rural nature of the parish and perhaps something to do with businesses.

Economic data is very similar to West Dorset apart from the spread of activity in that Stinsford has more people working in agriculture 11.9% vs 4.1% in WD and people working in education 17.6% vs 10.1 % in WD -NB LOW NUMBERS so may not be significant

Finally of interest (but not in the attached document) Stinsford is slightly less religious 61% than WD 66%

Stinsford 2011 Census Key Stats and Comparison with West Dorset (WD)

In 2011 Stinsford had 334 usual residents of whom 168 were male 50.3% (West Dorset pop 48% male)

90.4% of residents lived in households (WD 97%)

9.6% of residents lived in communal establishments (WD 2.7%)

There were a total of 149 household spaces

Of these 128 (85.9%) had at least one usual resident (WD 90%)

And 21 (14.1%) had no usual resident (WD 10%)

292 residents were over 16 years of age

25 were dependent children

5 were between 0-4 years of age

10 were schoolchildren in FTS

70 (47%) were whole house/ bungalow- detached (WD 37%)

50 (33.6%) were whole house/bungalow- semi. (WD 24%)

21 (14.1%) were terraced (WD 22.6%)

0 were purpose built flats (WD 11.4%)

4 (2.7%) were part of a house or shared house (WD 2.7%)

3 (2%) were flat/maisonette in a commercial building (WD 1.2%)

1 (0.7%) was a caravan/temp building (WD 1.1%)
